The proposal for remediation of the above referenced release, prepared and submitted to OCD by Tetra Tech, is approved with the following conditions/stipulations:

- Notify OCD District 2 office 48 hours prior to commencement of remedial activities.
- Notify OCD District 2 office 48 hours prior to obtaining samples where the analyses will be submitted to OCD.
- As indicated in the proposal, at the time of excavation, further delineation will be performed in the areas identified as AH-1, AH-2, AH-7, AH-8, AH-13, AH-19, and AH-20. Please advise OCD of the results of the delineation and excavation depths achieved, prior to backfilling.
- Advise OCD if any of the proposed excavation depths are not achieved, prior to backfilling.
- As indicated, please submit a hard copy of the work plan proposal.
- Submit a closure report and Form C-141 Final Report upon satisfactory completion of project.
- Like approval by any other regulatory authority as may be applicable.
