On April 16, 2014 at 10:30 AM fluid was noticed misting out of the flow line in the vicinity of the TNT 6 Fed Com 1, upon arrival it was discovered that the flow line possibly had a weak spot which resulted in a 3 inch by 1.5 inch slit that released an estimated .5bbl of mixed oil and produced water into pasture.

Describe Area Affected and Cleanup Action Taken.*

The affected area is approximately a 100x100 area in the pasture located northwest of the lease road leaving the TNT 6 Fed Com 1. 0bbls were recovered and the area will be raked and the surrounding vegetation will be pressure washed with Dawn soap.
