


Apache Corporation has retained Rice Environmental Consulting and Safety (RECS) to address environmental concerns at the Tony Federal Tank Battery discharge date (11/26/12). The discharge area has been excavated to a depth of 6in to a foot using a hand shoveling crew. A 5 point composite of the bottom was taken and delivered to a commercial laboratory to test for chloride and TPH 8015M. Chloride value was 496 and Total TPH was 560. Attached is a plat and photos of work performed on location. Since the discharge area is located in an area of no groundwater Apache Corporation request permission to backfill the site with clean imported caliche. RECS appreciates the opportunity to work with you on this project. Please call me if you have any questions or wish to discuss the site. Thanks and have a good day.





Unit Letter K&N, Section 186, T17S, R31E






Release area, facing south









Unit Letter K&N, Section 186, T17S, R31E






Release area, facing south
