Proposed SWD Well – Owl SWD Operating, LLC, McCloy SWD Well No. 1 Delaware Disposal 4800 to 7300 feet, Owl SWD Operating, LLC administrative application dated October 8, 2014

Dear Mr. Stone,

We are in receipt of your revised proposal to complete the proposed salt water disposal well into the Delaware formation through perforations from a maximum top of 5400 feet and a maximum depth of 5700 feet.

Limiting the disposal to this interval alleviates the State Land Office's ("SLO") concern that waste of oil and gas and therefore loss of royalties to the SLO beneficiaries would occur at the initial proposed interval of 4850 feet to 7300 feet into the Delaware formation.


Given the new proposed interval, the SLO hereby withdraws its objection filed with the Oil Conservation Division to the proposed salt water disposal well.

Gentlemen:

Last week, I advised you that Owl would like to withdraw the application due to our inability to negotiate a satisfactory interval w/ State Land Office. However, Owl has since reconsidered and we are having a conference call this afternoon to discuss the possibilities.

This was unexpected on my part. I have advised them that to conform with all the conditions, that the resulting interval would only be from 5400' to 5700' and would have to be cased and perforated. I think the net interval of good "disposable" porosity may be less than 100 feet.

I did not think this was a commercial zone and advised them of that and will do so again on the call this afternoon. However, as they are my client and it's their call, I may later today or tomorrow be advising concerned parties that they'd like to move forward.

If this turns out to be the case, I will contact COG, Red Mountain Resources and the SLO to advise them of the resurrection of the application and compliance with all of their interval stipulations.

I will let you know as soon as practicable.

Dear Ms. Bailey,

Per OCD rules, the State Land Office was notified of this proposed SWD to be drilled, completed, and equipped for disposal on State surface.

The State Land Office would like to protest the permitting of this proposed disposal well; and, if it is to be further considered, request it be scheduled for an examiner hearing.

It is our opinion that waste of oil and gas (and loss of royalties to the State Land Office) will occur as a result of this proposed SWD. This well is located in Section 15, Township 24 South, Range 32 East, in Lea County, New Mexico. The State Land Office owns the mineral estate in Section 16. The proposed well is located only 430 feet from the East line of Section 16.
