Mike,

This e-mail is to confirm our discussion on January 14, 2013 concerning the remediation plan for the release that occurred at the Oxy Cedar Canyon 28 Federal #4. I have attached the site drawing and the summary of the laboratory data we reviewed during our discussion for your files. As agreed, Oxy will excavate 2 feet in the areas covered by SP1, SP2, and SP3 and will excavate 3 feet in depth in the area covered by SP4. As discussed, an initial response to the spill was done immediately after the spill occurred and 1 foot of the impacted soil has already been removed. The depth referred to earlier in this e-mail is the total depths that will be removed not additional to what has already been removed. The site will then be backfilled with clean soil. The depth to groundwater in this area is approximately 75 feet.

If you would please reply back via e-mail with your concurrence of this remediation plan, it would be greatly appreciated.

Oxy and I thank you for your assistance in handling this matter.
