

Scale plugged the 2" polyline causing the line to rupture. The release occurred on location 10' north of pumping unit. A section of the polyline was removed from service; the line was repaired and then placed back in service.

Describe Area Affected and Cleanup Action Taken.*
An approximate area of 25' X 15'. The visibly impacted soils were excavated and taken to an OCD approved land disposal facility. Soil samples were taken and run for TPH & BTEX (chlorides are to show decreasing levels and for documentation). The excavation process was concluded and the area backfilled to grade using clean soils. **Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 10. Based on enclosed analytical reports and impacted soils removed/hailed to an NMOCD approve facility, Yates Petroleum Corporation is requesting final closure.**
