


Line 1002 pressure built up causing the release of natural gas to the atmosphere from a pipeline overpressure protection valve. Enterprise technicians isolated the valve and it will be replaced. No damage occurred to the pipeline, requiring no further response activities.

No liquid spills occurred requiring any cleanup actions.
