
**Describe Cause of Problem and Remedial Action Taken.\***

At the Aldabra 25-6 & 7 battery at 12:00 pm the 3 phase separator was blowing out of the gasket on water dump manway. Lease operator saw the gasket blowing a mist so he went to the battery and noticed it was the Aldabra 25-3 separator. He shut the well down and shut it in, he then went to battery and shut it at the header.

**Describe Area Affected and Cleanup Action Taken.\***

It was mostly in containment an over spray, went onto pasture. .25 bbl of oil and 1.75 bbl produced water was release and .25 BBL of oil and 1 BBL of produced water was recovered. The 15 X 20 area will be pressure sprayed with soap and water also evaluated by environmental group. Vendor called to replace gasket.
