Describe Cause of Problem and Remedial Action Taken.*
On June 15, 2015 11:40 PM Caprock Communication called Lease Operator with a high water tank level at the Arcturus 18 Fed 3H, upon Lease Operator's arrival the well had overflowed 80bbbls produced water and oil into lined containment. One of the oil tanks was immediately opened up to turn the incoming produced water to flow into until Legendary Trucking arrived on location and started pulling loads. After turning into oil tank Lease Operator started working on getting the water transfer pump operational. Foreman stated this occurred due to weather issues.

Describe Area Affected and Cleanup Action Taken.*
The affected area was a 100x50 inside lined containment. All 80bbbls were recovered from the lined containment and the containment will be pressure washed. The liner was checked for holes and none were found.
