This is to inform you that Oxy Permian had a leak at the Shugart 6 Fed Com #1 Battery on June 8, 2015. Oxy spilled 8 bbls of oil due to corrosion causing a hole in the north oil tank. The preliminary report shows the leak measuring approximately 80' x 80' both on and off location. No fluids were recovered. The release is located in the NE ¼ of Section 6, T18S, R31E of Eddy County, NM. BBC International will remediate the location at a later date and an initial C-141 will follow. Driving directions: At the intersection of CR222 and CR250, go north on CR222 for 3.8 miles, turn west and go 1.4 miles, turn north and go 0.5 mile, go back east 0.2 mile to location. API# 30-015-31313, No GPS available at this time.
