


A truck driver ran over a tank spilling 30 bbls of oil and 30 bbls of produced water into the metal containment. A vacuum truck recovered 55 bbls of fluid and preventative measures were taken to prevent future accidents.

Describe Area Affected and Cleanup Action Taken.*
The affected area is approximately 105' x 60' on location inside the metal containment. Remediation will be completed in accordance with a remediation plan approved by NMOCD and the BLM.

This is to inform you that Oxy Permian had a leak at the Lost Tank 3-25 SWD Facility on July 7, 2015. Oxy spilled 30 bbls of oil and 30 bbls of produced water due to a third party truck driver running over a tank. The preliminary report shows the leak measuring approximately 30' x 30' on location inside the berm. Approximately 55 bbls of fluids were recovered. The release is located in the NE ¼ of Section 3, T22S, R31E of Eddy County, NM. BBC International will remediate the location at a later date and an initial C-141 will follow. Driving directions: From Hobbs, go west on US62/180 to mile marker 65, turn left on Whipp Rd and go 7 miles to 0.25 mile past mile marker 5, turn left onto lease road and go 0.8 mile veering left 0.25 mile, turn right onto location.
