Attached is a C-107A application and attachments to downhole commingle the Blinebry Oil & Gas (Oil-06660), Drinkard (19190), Tubb Oil & Gas (Oil-60240), and Wantz-Abo (62700) Pools within Breitburn's Encore M State Well No. 10.

This well is currently producing under DHC-HOB 518, with allocation identical for the Drinkard (19190) and the Wantz-Abo (62700) Pools: 50% Oil, 50% Gas, 50% Water.



Given the close proximity of the Encore M State No. 10 to the Encore M State Nos. 008 and 016, supporting data for these wells will be used to establish an allocation of 25% for each zone as indicated on the attached C-107A.




