Matador Production Company (OGRID No. 228937) seeks administrative approval of an unorthodox well location for its Rustler Breaks 12-24S-27E RB #207H (API 30-015-pending) to be completed within the Black River Wolfcamp East Gas pool (Pool Code 97442) underlying Section 12, Township 24S, Range, 27E, Eddy County, New Mexico. Attached as **Exhibit A** is a plat for the well. This well is a horizontal well that will be drilled as follows:

- Surface Hole Location: 350 feet from the South line and 300 feet from the East line of Section 12;
- First Perforation Point: 1040 feet from the South line and 330 feet from the East line of Section 12;
- Last Perforation Point: 1040 feet from the South line and 330 feet from the West line of Section 12; and
- Bottom Hole Location: 1040 feet from the South line and 240 feet from the West line of Section 12.

Matador Production Company is requesting this NSL in order to efficiently produce its interests in Section 12. This well is producing from the Black River Wolfcamp East (Gas) pool (Pool Code 97442). There are no special pool rules for this pool, and thus the setback requirements under Rule 19.15.15.10(B) of 660' apply. As a result, the completed interval for this well encroaches on the adjoining spacing units in Sections 11, 13, and 14 in
