McElvain Energy, Inc. (OGRID No. 22044) seeks administrative approval of an unorthodox well location for its **EK 29 BS2 Federal Com No. 4H Well** to be completed within the E-K; Bone Spring Pool (Pool Code 21650) underlying Section 29, Township 18 South, Range 34 East, N.M.P.M., Lea County, New Mexico. This well will be drilled from a surface location 175 feet from the South line and 100 feet from the East line (Unit P) of Section 30. The first perforation will be located 330 feet from South line and 725 feet from the West line (Unit O) and the last perforation will be 330 feet from the North line and 656 feet from the West line of Section 29 (Unit B). The E-K; Bone Spring Pool is governed by the Special Rules as adopted by Division Order R-4981. These Special Rules require 80-acre spacing units and further require that the completed interval for a well be located within 150 feet of the center of the quarter-quarter section. As a result, the completed interval for this proposed well will be unorthodox because it is closer than 510 feet from the northern, southern, and southeastern boundaries of the project area. Approval of the unorthodox completed interval will allow for efficient spacing of horizontal wells and thereby prevent waste.

Exhibit A is the Well Location and Acreage Dedication Plat (Form C-102), which shows that the completed interval of the proposed **EK 29 BS2 Federal Com No. 4H Well** encroaches on the spacing and proration units to the North, South, and Southeast.

Exhibit B is a land plat for Section 29 and the surrounding sections that shows the proposed **EK 29 BS2 Federal Com No. 4H Well** in relation to adjoining units and existing wells.




