






PICT. CLIFFS HISTORICAL DATA: 1ST PROD: 12/75







The Farmington District Office (FDO) of the Bureau of Land Management (BLM) has received your correspondence dated December 17, 1996, for downhole commingling of the Blanco Pictured Cliffs and Blanco Mesaverde Formations in the above referenced well.

The current bottom hole pressures are 297 psia for the Mesaverde and 322 psia for the Pictured. The average daily production for the month of September 1996 was 269 Mcfpd and .6 Bopd for the Mesaverde and 283 Mcfpd and .1 Bopd for the Pictured Cliffs. Using these values, the fixed percentage allocated production for each formation has been determined as follows:

FORMATION	GAS PRODUCTION	OIL PRODUCTION
Pictured Cliffs	51%	14%
Mesaverde	49%	86%

Approval to downhole commingle the Blanco Pictured Cliffs and the Blanco Mesaverde formations for the above referenced well is hereby granted.

Under provisions of 43 CFR 3165.3, you may request an Administrative Review of the order(s) described above. Such request, including all supporting documents, must be filed in writing within 20 business days of receipt of this notice and must be filed with the State Director, Bureau of Land Management, P. Procedures governing appeals from instructions, orders or decisions are contained in 43 CFR 3165.4 and 43 CFR 4.400 *et seq.*
