Dear Sir:

McQuadrangle LLC would like to obtain administrative approval to drill captioned well at the above location. The reason for moving well location East is that the original location 1950' FNL & 2310' FWL would have placed well in the center of the road and approximately 45 ft. East of a power line. Between power pole and road there are nine flow lines and 5 ft. West of pole there are three flow lines. If above request is granted it would eliminate having to move twelve flow lines and the power line. Attached is a plat of the 40 acre proration unit showing above obstacles and both original and unorthodox locations;

The 40 acre proration units to the North, Northeast, and East of proposed well are all owned by McQuadrangle. The ownership in the Upper San Andres for West proration unit could not be determined. Consequently, no notification was sent out. This proration unit should not be effected as it 1055 ft. West of proposed well. Attached is a plat showing proposed well and acreage owned by McQuadrangle.






SOUTH REDLAKE SAN ANDRES FIELD
