

Gentlemen:

McKay Oil Corporation desires to drill a Federal lease in the NW/4 of Section 12, Township 6 South, Range 22 East, NMPM (See Attachment "A). Due to topography and geological problems, McKay Oil is requesting an unorthodox location.

The well was originally staked at 660' feet from the North line and 1980' feet from the West line. However, the Bureau of Land Management would not approve this location due to archeaological finds. Also, due to topographical reasons in this quarter section, the location had to remain in that vicinity (See attachment "B").

Further, the Northeast quarter of this quarter section was chosen because of geological data on wells to the North and East. Therefore, it is our opinion that this location would be the only economical and productive location to drill (See attachment "C").

All minerals surrounding this proration unit is leased to McKay Oil Corporation, with the exception of Mesa (See Attachment "A"). Mesa has been notified of this proposed location and no objection is forseen (See enclosed copy of letter). A copy of the executed letter and/or return receipt will be forward upon receipt.

McKay Oil Corporation would request and appreciate your immediate attention to this matter. Thank you for your cooperation and assistance.






