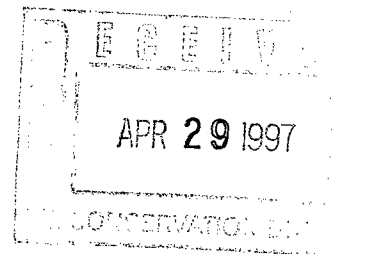

Being sympathetic to the circumstances surrounding the non-delivery of the twenty-two downhole commingling applications within the San Juan 28-7 Unit which were originally mailed on February 3, 1997, and your dilemma with regards to rig crews, I specifically reserved valuable time this week in an attempt to process these applications.

Upon initial review of these applications, I was concerned that if the Division did not receive the original applications, it was possible that the interest owners entitled to notice pursuant to Rule 303.C. may have not received notice as well. I attempted to locate the notification list of working, royalty, and overriding royalty interest owners, which, pursuant to Form C-107-A, is supposed to be attached to the applications. I found that no such list was furnished. Please be advised that I cannot process the applications without having proof that all interest owners have been sent, via certified mail, notice of Conoco's intent to commingle. Please furnish a list of these interest owners as well as certified mail receipts, if available, as soon as possible so that we may continue to process these applications.

With regards to your request for a contact person within OCD to verify if applications have been received, in the future please contact Ms. Kathy Valdez at (505) 827-8182. All mail for the Engineering Bureau is funneled through Ms. Valdez who enters applications into our administrative order database and then forwards the applications to the appropriate engineering personnel. Ms. Valdez does not recall, nor does the database reflect, that the original subject downhole commingling applications were received by the Division.

Lastly, please be advised that I have not received an E-Mail message from yourself or Conoco concerning the subject downhole commingling applications. Fortunately, my computer maintains a permanent record of E-Mail messages received, even after I have read and deleted them. This record confirms no receipt of such an E-Mail message.
