Dear Mr. Cogburn:

We are in receipt of your application of April 4, 1997, requesting our approval to downhole commingle the production from the above subject well from the Southeast Lea Wolfcamp and Osudo Morrow West Pools in Lea County, New Mexico.

It is your understanding that the Southeast Lea Wolfcamp has a current stabilized production rate of 4 BOPD, 0 BWPD, AND 20 MCFGPD. After the Osudo Morrow West formation is open to production, the Morrow production will be determined by subtracting the established Wolfcamp production rate from the total commingled production rate. A test period of one month will be used to obtain a stabilized rate prior to submitting the allocation formula. Please submit a copy of the allocation formula to this office when completed.

Since it appears that there will be no loss of revenue to the State of New Mexico as a result of your proposed operation, your request for downhole commingling the production from the above-mentioned well is hereby approved. Any deviation from the substance of your request will be sufficient grounds for rescinding our approval. Our approval is subject to like approval by the New Mexico Oil Conservation Division.
