NMOCD District 2 well inspection records indicate three produced fluid releases occurred at or near the above referenced well site. Records indicate the releases occurred during the time frame of July 2010 – September 2010. The well was being flowed back into a temporary tank set on location. The tank was allowed to overflow on at least three separate occasions, impacting a large area which includes the well pad, adjacent pasture land to the west and south of the site and a portion of Buckaroo Road (County Road 232). Some preliminary remedial work was performed at the site (some surface soils were scraped into stockpiles), however, NMOCD has no record of Alamo having submitted the required Form C-141s, or any other documentation related to the release incidents.

Please advise what the current status is, and, Alamo's intent for remedial actions, pertaining to these release incidents.
