Area affect is approx 400' x 1' and 10'x20' in the track of the pipeline right of way, with a pooling area at the end of the release. The release originated at the top of an elevated area and traveled downhill. The spill is approx. 150-200 yards north of the Gissler A 2 tank battery. Impacted area will be sampled and cleaned up according to regulatory requirements. Clean up plan will be submitted as soon as developed.
