Matador Production Company (OGRID No. 228937) seeks administrative approval of an unorthodox well location for its Jimmy Kone 05-24S-28E RB #228H well (API No. pending) to be completed within the Culebra Bluff, Wolfcamp, South (Gas) pool (Pool Code 75750) underlying the S/2 of Section 5, Township 24S, Range, 28E, Eddy County, New Mexico. Attached as **Exhibit A** is C-102 for the well. This is a horizontal well that will be drilled as follows:

Jimmy Kone 05-24S-28E RB #228H

- Surface Hole Location: 161 feet from the South line and 380 feet from the West line of Section 4, Township 24 South, Range 28 East;
- First Perforation Point: 330 feet from the South line and 330 feet from the East line of Section 5;
- Last Perforation Point: 330 feet from the South line and 330 feet from the West line of Section 5; and
- Bottom Hole Location: 330 feet from the South line and 240 feet from the West line of Section 5.

Matador Production Company is requesting this NSL in order to efficiently produce its interests in Section 5. This well is producing from the Culebra Bluff, Wolfcamp, South (Gas) pool (Pool Code 75750). There are no

special pool rules for this pool, and thus the setback requirements under Rule 19.15.15.10(B) of 660' apply. As a result, the completed interval for this well is closer than 660' from the boundary of the project area. The unorthodox location will encroach towards Section 8, the E/2 and the NW/4 of Section 7, the W/2 and NE/4 of Section 9, the E/2 and SW/4 of Section 6 and the W/2 and SE/4 of Section 4. **Exhibit B** is list showing the surrounding ownership and the project area for the proposed Jimmy Kone 05-24S-28E RB # 228H well in relation to adjoining units.

Exhibit C is a list of the parties affected by the encroachment. Each of these parties have been provided notice of this application by certified mail, return receipt requested, advising them that if they have any objection to this well, it must be filed with the New Mexico Oil Conservation Division within 20 days of the mailing of this notice.
