The affected area is approximately 150' x 60' on location around the tanks inside the containment. Remediation will be completed in accordance with a remediation plan approved by NMOCD and the BLM.

This is to inform you that Oxy Permian had a leak at the Cypress 34 Federal #1 CTB on January 5, 2016. Oxy spilled 25 bbls of produced water and 15 bbls of oil. The facility is a lined containment all fluids stayed in the containment. 36 bbls of fluids were recovered. The release is located in U/L P of Section 34, T23S, R29E of Eddy County, NM. BBC International will remediate the location at a later date and an initial C-141 will follow. Driving directions: At NM 128, go South on CR793 (Rawhide Rd) for 4.0 miles, turn right and go West on the main road for 3.5 miles, turn left at Oxy sign and go 2.7 miles down the main road to location on the left or North side of the road.
