

This message is to confirm our discussion on March 12, 2013 concerning the remediation plan for the Oxy SHU Injection #87 site. I have attached the site diagram and lab data summary table that we used in our discussion. As mutually agreed, Oxy will excavate to a depth of 4 feet across the entire leak site and then backfill the site with clean soil.
