A repair clamp on a buried 4 inch fiberglass line failed resulting in the loss of fluid. The line was isolated and a vacuum truck was dispatched to pick up standing fluid.

The entire release was in the pasture. The area was mapped and a one call placed to permanently repair the line. Once the site is delineated a corrective action plan will be submitted.
