I apologize for my delayed response, I have been working down around Mentone TX, and communications are almost non-existent. At the Turner B #127 leak site I have been able to get samples from 20' bgs, as deep as we could safely get with a backhoe, and the chloride level was lower, however, the TPH was higher. Due to the soft sand at the site it is going to be very difficult to get a drilling rig into the site. We are going to try and use an excavator to collect the deeper samples but as you know, heavy equipment in New Mexico is backlogged and nobody wants to break loose for a small 1-2 day job. I have been trying to locate an extendable excavator that I can lease to get out there, but they are few and far between. If one does not turn up pretty quick, I will go ahead and get on the schedule with somebody. Thank you for your patience.
