


Water trucks have been assigned to a regular schedule to haul water from the Yale TB to eliminate this from occurring again in the future.</b>		
Describe Area Affected and Cleanup Action Taken.* <b>Tetra Tech inspected site and collected samples to define spills extent. A work plan was submitted and approved. Soil with elevated chloride concentrations was removed and hauled away to Controlled Recovery, Inc., Hobbs, NM. Site was then brought up to surface grade with clean backfill material. Tetra Tech prepared closure report and submitted to NMOCD for review.</b>
