This is to inform you that Oxy Permian had a leak at the Smokey Bits State Com #2H on December 2, 2015. Oxy spilled 150 bbls of produced water due to a 3rd party frac tank spill. The preliminary report shows the leak measuring approximately 5' x 400' both on and off location close to well 6H. No fluids were recovered. The release is located in U/L E of Section 36, T18S, R30E of Eddy County, NM. BBC International will remediate the location at a later date and an initial C-141 will follow. Driving directions: From Carlsbad, go east on US 62/180 to NM360, turn left and go to NM222, turn right and go 8 miles to Grubbs Rd, turn left and go 1 mile, turn left on lease road and go 0.75 mile, turn right to location.
