

BP America respectfully requests administrative approval for a non-standard location for the above referenced well. Attached for your reference are the following exhibits:



BP America Production Company would like to drill a horizontal well in the Basin Mancos formation, which is within the Basin Mancos Pool (97232) in a project area of a 640 acre unit. It is anticipated the bottom hole location or "toe" of the lateral will be 330' from the west lease line of Section 34-T28N-R12W, as it was determined that this bottom hole location was the best end point for our horizontal lateral. The rules state that the well should have setbacks of 660 feet of the quarter section lines, therefore, this existing location will not conform to the required footages.

BP America Production Company, Burlington Resources Oil & Gas, and Energen Resources are the offset operators in the Gallegos Canyon Unit, therefore notification of the non-standard location application is required and has been sent by certified mail to Burlington Resources Oil & Gas and Energen Resources. The above captioned horizontal Basin Mancos well is planned to be drilled sometime in 2017. The surface location and lateral of this well meet the 660' lease line setback rule as required by the NMOCD. It is anticipated the end or "toe" of the lateral will be 330' from the west lease line of Section 34-T28N-R12W. Since the "toe" of this lateral does not meet the required 660' setback for a Basin Mancos well, BP America, as Operator of this well, must apply for an exception to this set back rule as it applies to the "toe" of this lateral.
