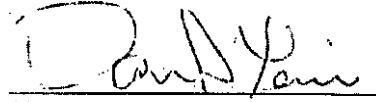

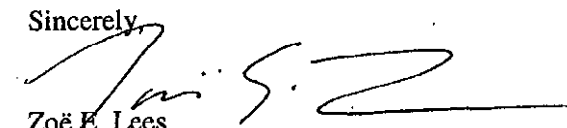

Matador Production Company (OGRID No. 228937) seeks administrative approval of an unorthodox well location for its Charlie Sweeney 31-23S-28E RB #221H well (API No. pending) to be completed within the East Black River-Wolfcamp Gas Pool (Pool Code 97442) underlying the W/2 of Section 31, Township 23S, Range, 28E, Eddy County, New Mexico. Matador Production Company is requesting this NSL in order to efficiently produce its interests in Section 31. This well is producing from the East Black River-Wolfcamp Gas Pool (Pool Code 97442). There are no special pool rules for this pool, and thus the setback requirements under Rule 19.15.15.10(B) of 660' apply. As a result, the completed interval for this well is closer than 660' from the boundary of the project area. The unorthodox location will encroach towards the S/2 and NW/4 of Section 30, E/2 of Section 36 and the S/2 and NE/4 of Section 25, Township 23 South, Range 27 East, the N/2 and SW/4 of Section 1, Township 24 South, Range 27 East, and the N/2 and SW/4 of Section 6, Township 24 South, Range 28 East. **Exhibit B** is list showing the surrounding ownership and the project area for the proposed Charlie Sweeney 31-23S-28E RB #221H well in relation to adjoining units.
