The majority of the release was contained in the bermed area a 3' X 10' area in the pasture. The majority of the fluid was burnt up in the fire. Concho has replaced the fire tube on the heater treater and will have the spill site sampled to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation work.
