| A hole developed in the fire tube at the heater treater inside the tank battery. This caused the heater to catch fire and burn a flow line. The fire tube has been repaired. | | | | | |

| Initially 12bbbls of fluid were released from the flow line and we were able to recover 10bbbls with a vacuum truck. The spill was contained inside the dike walls of the tank battery with exception of a small overspray area outside of the dike. The overspray area has been treated with Micro-blaze. Tetra Tech will sample the spill site area to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation work. | | | | | |
