Describe Cause of Problem and Remedial Action Taken.*

An 8" poly line from the H pump to the booster pump ruptured. Valves upstream and downstream were closed, the water pump was turned off and the water line was isolated.

Describe Area Affected and Cleanup Action Taken.

The affected area was inside the lined/bermed battery, along parts of the east and south side of the location and an 18' x 10' area off of the production pad. The release area was scraped and soils were hauled to a NMOCD approved facility. Vertical and horizontal delineation samples will be taken from the release area and analysis will be run for TPH & BTEX (chlorides for documentation). If initial analytical results for TPH & BTEX are under RRAL's (site ranking is 0) a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL's a work plan will be submitted to the OCD. **Depth to Ground Water: >100' (approximately 300', per Chevron/Texaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0.**
