The combined project area for these wells include the Entire Section 6, and Entire Section 7 Township 25 South, Range 32 East, NMPM, Lea County, New Mexico.

The commingled and gas production from the wells detailed above shall be measured and sold at the Cotton Draw Unit No. 7 Central Tank Battery (CTB), located in Unit C, Section 7, Township 25 South, Range 32 East, NMPM, Lea County, New Mexico.

Production from the subject wells shall be determined as follows:

The oil and gas production from each of the wells in this application shall be separately metered.

Subsequently drilled wells that produce from the subject pool within the project areas approved by this order may be added to this commingling authority by submittal of a Sundry Notice to the Engineering Bureau in Santa Fe.

The allocation meters shall be calibrated quarterly in accordance with Rule 19.15.12.10.C (2).

The operator shall notify the Hobbs District office of the Division prior to implementation of the commingling operations.
