This is to inform you that Oxy Permian had a release at the Rocky Hills SWD #001 on June 25, 2016. Oxy released 7 bbls of produced water due to a compromised 8" steel disposal line. No fluids were recovered. The preliminary report shows the leak measuring 20'x 80' off location approximately 150' west of the well head.
