This release was caused by a hole in the heater treater. A vacuum truck was dispatched to recover free liquids and Microblaze was applied to the pasture areas.

Describe Area Affected and Cleanup Action Taken.*

This release occurred primarily in the containment however a spray of fluids impacted the nearby pasture. Concho will have the spill site sampled to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation work.
