This release occurred when hose connection failed going to a load line on the pad. A 5X5 area went off in the pasture next to the location. Concho will have the spill site sampled to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation work.


