This release was caused when lightning struck the facility. The damage was found during the morning route and no fire was reported with the incident. Vacuum trucks were dispatched to recover all standing fluid.

Describe Area Affected and Cleanup Action Taken.*
The majority of the release remained within the bermed area; however a light spray impacted the pasture. A portion of the facility was a total loss. Concho will have the spill site sampled to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation work.
