A gun barrel surge caused 10 bbls of oil to leak inside the lined containment on location. A vacuum truck recovered all free-standing fluid.

The affected area is approximately 80' x 4' inside the lined containment on location. Remediation will be completed by removing the contaminated material and replacing it with clean material.

This is to inform you that Oxy Permian had a leak at the SDS 11 Federal #1 SWD on August 8, 2016. Oxy released 30 bbls oil due to a gun barrel surge. The preliminary reports show the leak measuring 80' x 4' inside lined containment on the facility. Recovery efforts are in progress. The release is located in Section 11, T24S, R31E in Eddy County, NM. Driving directions: Go East on NM128, turn south on Buck Jackson Rd and go 1.5 miles, turn west and go 150', take right at the "Y" and go 2.5 to 3 miles to 1st lease road on right.
