NEXT DAY NOTIFY BLM & NMOCD ON PHONE GOT PERMISSION TO START REMOVING CONTAMINATED SOIL TO PLASTIC LINER. ONCE SOIL IS REMOVED SAMPLES WILL BE TAKEN TO CARDINAL LABS IN HOBBS, NM. ONCE ALL CONTAMINATION IS REMOVED AND PROPERLY DISPOSED OF WE WILL BACKFILL WITH PROPER SOIL AND RESEED IF NECESSARY. ALL REPAIRS WILL BE MADE TO BATTERY AND BURM BUILT. ALL PAPERWORK WILL BE FILED ACCORDINGLY.

AFFECTED AT BATTERY THEN RUNS APPROX. 105' SOUTHEAST TO CALICHE ROAD THEN 330' SOUTH ON ROAD. 15 BBLs RECOVERED NIGHT OF SPILL, START REMOVING CONTAMINATED SOIL TO PLASTIC LINER AS OF THIS REPORT.
