Describe Cause of Problem and Remedial Action Taken.*
Due to erosion the main steel transfer line for the Salt Water Disposal developed a hole. The line was immediately shut in to stop the release. Repairs have been made and the line is back in service.

Describe Area Affected and Cleanup Action Taken.*
Approximately 15bbls produced water was released in the right of way from the produced water transfer line that carries water to the Cotton Draw Unit SWD 181. This part of the transfer line is located nearest to the Cotton Draw Unit 167H Battery. All fluid stayed in the right of way in approximately an 80'x45' area. 0bbls produced water was recovered from the right of way. An environmental agency will be contacted for remediation.
