EOG Resources, Inc. (OGRID No. 7377) seeks administrative approval of an unorthodox well location for its **Della 29 Fed Com No. 602H Well** to be completed within the Lea; Bone Spring (South) Pool (Pool Code 37580) underlying Section 29, Township 20 South, Range 34 East, N.M.P.M., Lea County, New Mexico. This well was drilled from a surface location 250 feet from the South line and 1,300 feet from the East line (Unit P) of Section 29. The upper most perforation is located 455 feet from South line and 1,214 feet from the East line (Unit P) and the lower most perforation will be 330 feet from the North line and 1,194 feet from the East line (Unit A) of Section 29. Since this acreage is governed by the Division's statewide rules which provides for wells to be located no closer than 330 feet to the outer boundary of the spacing unit, the completed interval for this well will be unorthodox because it is closer than 330 feet to the northwestern and western boundaries of the project area. Approval of the unorthodox completed interval will allow for efficient spacing of horizontal wells and thereby prevent waste.

Exhibit A is an as-drilled plat for the **Della 29 Fed Com No. 602H Well** which shows that the completed interval encroaches on the spacing and proration unit to the Northwest and West.

Exhibit B is a land plat for Sections 29 and the surrounding sections that shows the **Della 29 Fed Com No. 602H Well** in relation to adjoining units and existing wells.

Exhibit C is spreadsheet showing the parties affected by the encroachment to the Northwest and West. Each of these parties has been provided notice of this application by certified mail. A courtesy copy of this application has been sent to the Bureau of Land Management—Carlsbad Field Office.





Hi Leonard,

As an initial matter, ownership throughout Section 29 is identical—all of the parties noticed in the W/2 E/2 have identical ownership in the E/2 E/2. While EOG does not currently have a well scheduled to be drilled in the W/2 E/2, they plan to drill this well and will evaluate the W/2 E/2. EOG has informed me that it would be a logical next drilling place. EOG spaced this well off of an existing horizontal well in the W/2 W/2 of Section 28 and believes that this is the most efficient spacing for wells in the area. The BLM has approved this permit, including the surface location, pending approval by the Division. They have also been provided notice of this request.
