A faulty check valve on the water transfer pump caused 200 bbls of produced water to leak inside the lined containment. A vacuum truck recovered all of the fluid and the valve was returned to service.

Describe Area Affected and Cleanup Action Taken.*

The affected area is approximately 140' x 50' inside the lined containment on location. Remediation was completed by recovering all the fluid within the containment.
