


Describe Cause of Problem and Remedial Action Taken.\*

There was a failure of a pressure gauge on the well head that caused the release.

Describe Area Affected and Cleanup Action Taken.\* The release impacted an approximate area of 75' X 50' on the production pad around the wellhead. A vacuum truck was dispatched to retrieve standing fluid and a backhoe contracted to excavate impacted soils. Impacted soils will be excavated and hauled to a NMOCD approved facility. Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX (chlorides for documentation). If initial analytical results for TPH & BTEX are under RRAL's (site ranking is 10) a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL's a work plan will be submitted to the OCD. **Depth to Ground Water: 50-99'** (approximately 70', Section 16, T19S-R25E, per Trend Map), **Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 10.**
