Pursuant to your application received on November 23, 2016, Chevron USA Inc. (OGRID 4323) is hereby authorized to surface commingle oil and gas production from the following pools:

The commingled oil and gas production from the wells detailed above shall be measured and sold at Jordan 12 Well No. 2 central tank battery (CTB) in Unit D of Section 12, Township 10 South, Range 32 East, NMPM, Lea County, New Mexico.

Production from the subject wells shall be determined as follows:

The oil and gas production from the diversely-owned wells and leases shall be measured using a combination of well testing and allocation meters.

*After initial notification, future wells that will produce from the pools and leases approved by this order may be added to this commingling authority by submittal of a Sundry Notice to the Engineering Bureau in Santa Fe.*

This installation shall be installed and operated in accordance with the applicable Division Rules. It is the responsibility of the producer to notify the transporter of this commingling authority.

**This approval is subject to like approval from New Mexico State Land Office before commencing commingling operations.**

The operator shall notify the Hobbs District office of the Division prior to implementation of the commingling operations.
