EOG Resources, Inc. (OGRID No. 7377) seeks administrative approval of an unorthodox well location for its **Braswell 16 State No. 707H Well** to be completed within the WC-025 G-09 S263327G; Upper Wolfcamp Pool (Pool Code 98097) underlying Section 16, Township 26 South, Range 33 East, N.M.P.M., Lea County, New Mexico. This well will be drilled from a surface location 270 feet from the North line and 800 feet from the West line (Unit D) of Section 16. The upper most perforation will be located 330 feet from North line and 1,210 feet from the West line (Unit D) and the lower most perforation will be 330 feet from the South line and 1,210 feet from the West line of Section 16 (Unit M). Since this acreage is governed by the Division's statewide rules which provides for wells to be located no closer than 330 feet to the outer boundary of the spacing unit, the completed interval for this well will be unorthodox because it is closer than 330 feet to the eastern, southeastern, and northeastern boundaries of the project area. Ownership in the W/2 of Section 16 is common, and EOG is the operator in the adjacent spacing unit to the West of the proposed **Braswell 16 State No. 707H Well**. Therefore, there are no affected parties in the spacing unit to the East. Approval of the unorthodox completed interval will allow EOG to use their preferred well spacing plan for horizontal wells in this area and thereby prevent waste.

Exhibit A is a draft Well Location and Acreage Dedication Plat (Form C-102), which shows that the completed interval of the proposed **Braswell 16 State No. 707H** encroaches on the spacing and proration units to the East, Northeast, and Southeast.

Exhibit B is a land plat for Section 16 and the surrounding sections that shows the proposed **Braswell 16 State No. 707H** in relation to adjoining units and existing wells.

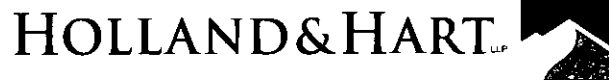

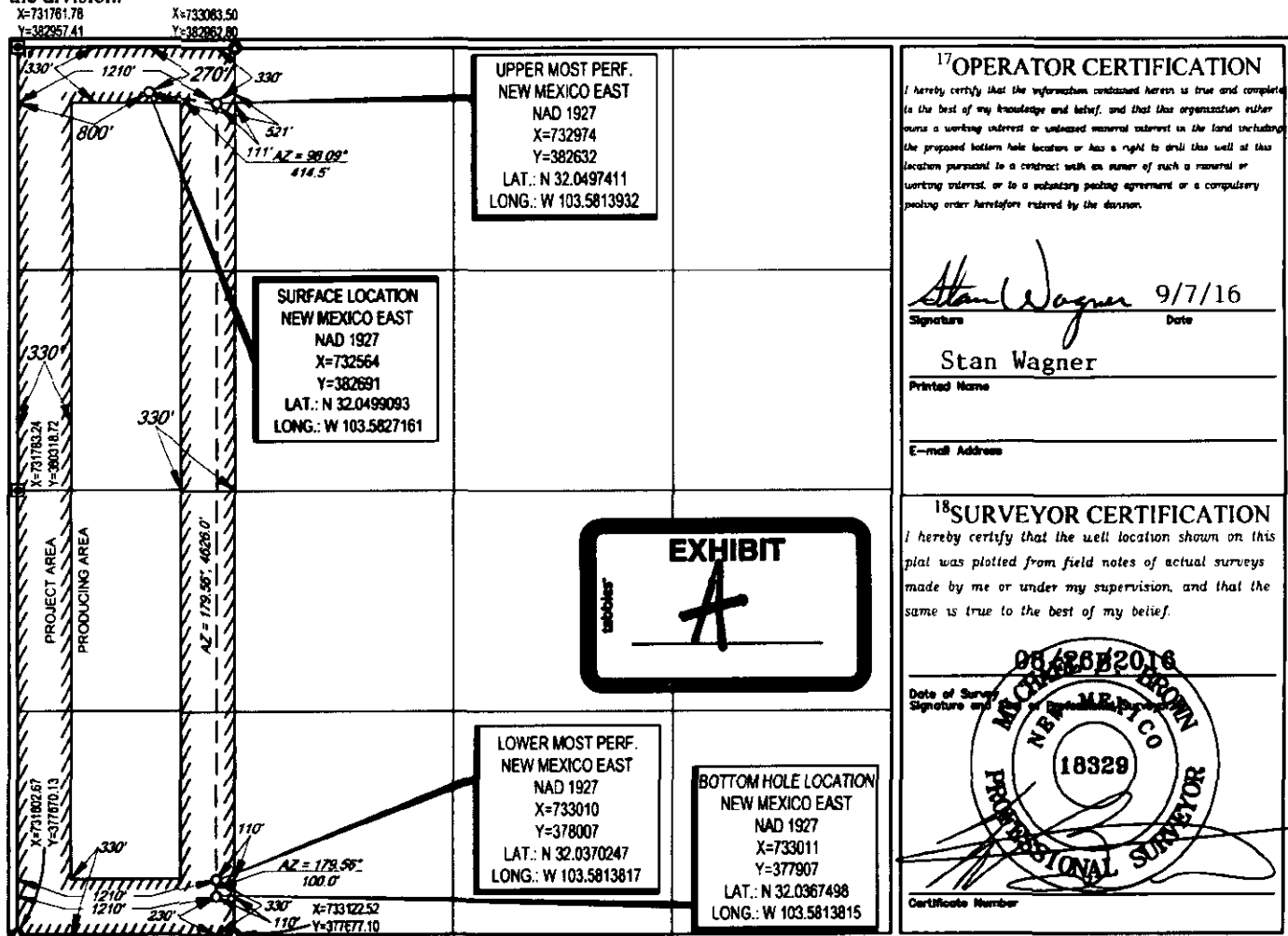

SECTION 16 TOWNSHIP 26 SOUTH RANGE 33 EAST, LEA COUNTY, NM**

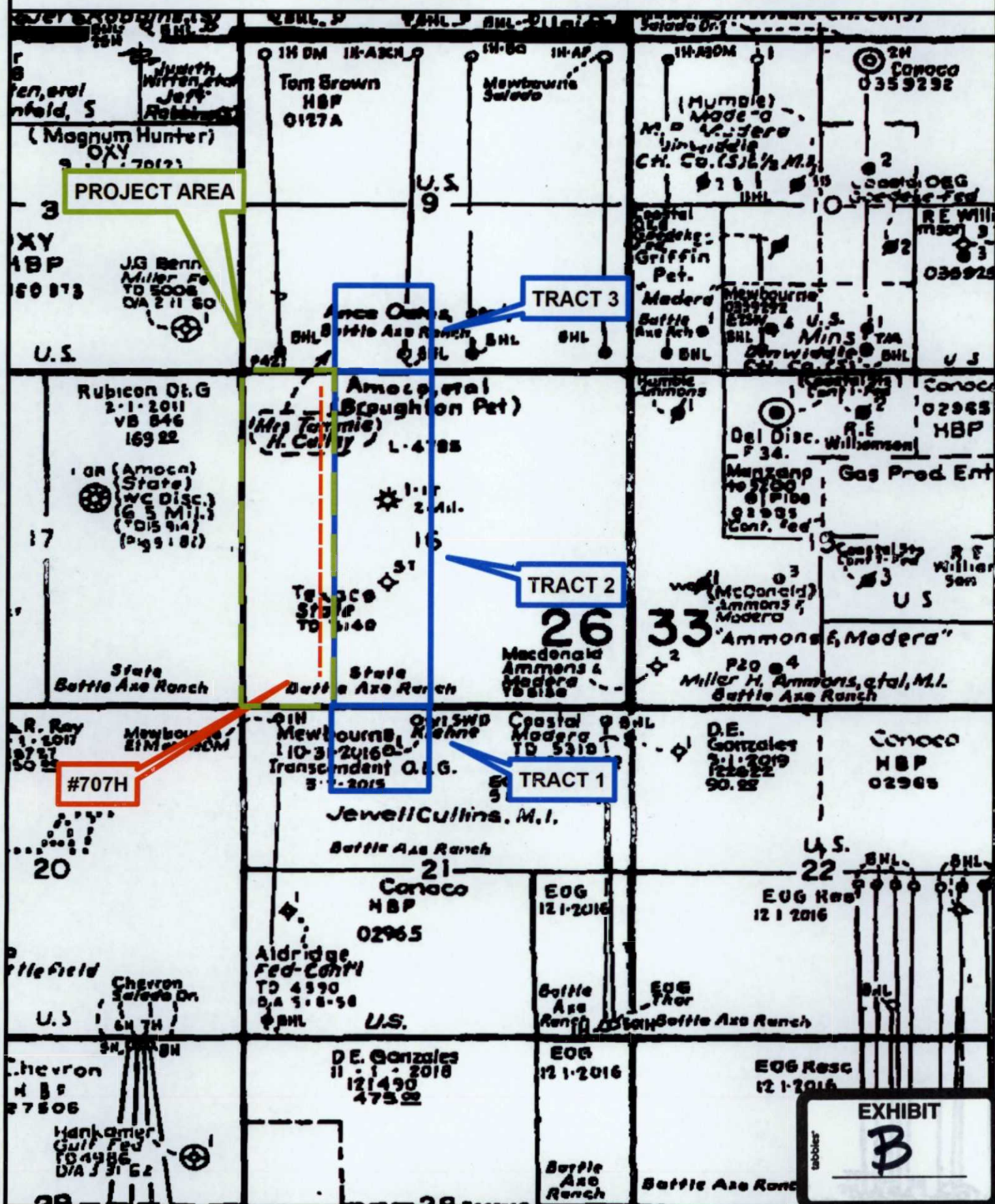
