This is to inform you that Oxy Permian had a release at the Cedar Canyon 16 SWD #003 on December 18, 2016. Oxy released 2 bbls of oil and 4 bbls of produced water due to a frozen valve causing a skim tank spill. The preliminary report indicates that the leak measures 40' x 40' on location inside the lined containment. A vacuum truck recovered all the fluid. The release is located in U/L D, Section 16, T24S, R29E in Eddy County, NM. Driving directions: From Carlsbad, go South on US285 to Malaga, turn left on Duarte Rd, turn right on McDonald Rd, turn left on Dogtown Rd, cross the river, turn left and follow road to the first right, stay on road to the next first right to location.
