Ball valve on the fiberglass produced water tank froze and broke. Vacuum truck(s) and roustabout crews were called.

An approximate area of 30' X 70' within the lined and bermed battery. Vacuum truck recovered all the produced water, with the liner in very good condition. The valve was repaired and the well put back into service. Depth to Ground Water: 50-99' (approximately 65', per ChevronTexaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 10. Based on the battery being lined/bermed, EOG Y Resources, Inc. requests closure.
