

BP America respectfully requests administrative approval for a non-standard location for the above referenced well. Attached for your reference are the following exhibits:

The above captioned horizontal Basin Mancos Gas well is planned to be drilled sometime in the 2nd quarter of 2017. It is anticipated the deepest take point of the lateral will be 250' from the east lease line of Section 18-T31N-R06W, San Juan County, NM. Since the deepest take point does not meet the required 660' setback for a Basin Mancos Gas well, BP America, as Operator of this well, must apply for an exception to this set back rule as it applies to the last take point and notify the offset Operator. BP is requesting an unorthodox location for the toe of the NEBU 604 Com 2H well to avoid stranding reserves which allows us to capture additional reserves in the wellbore. WPX is the sole offset operator for the unorthodox location of our last take point in the subject well and have been notified by certified mail.
