Dear Sirs,

Chevron U.S.A. Inc. respectfully requests administrative approval to surface commingle oil, gas and water production from the Langley Strawn Pool through Chevron's Langley Greer 4 Central Tank Battery. Chevron requests the approval to minimize surface disturbance, future traffic and reducing spill risk by concentrating activities at one battery. Wells producing to this battery include the Langley Boren #2, Langley Boren #3, Langley Greer #1, Langley Greer #2, and Langley Greer #4. These wells are located in Section 20 and 21, T 22S, R 36E in Lea County, New Mexico.

The working interest varies among the wells but the royalty rate is the same for all leases involved in this request. These wells were completed in 1978, 1988, 1990, 1991, & 2008. Each well will be tested monthly through turbine meters installed on the three phase separator and the gas allocation meter. There are two oil tanks at the CTB that the wells utilize and total oil will be measured by having a qualified field personnel gauge. Each well will be tested monthly through a three phase separator located at the Langley Greer 4 CTB. Oil and water are measured by a turbine meter on the oil and water outlets and gas is measured by an orifice meter on the gas outlet.

**Oil & Gas metering:**

The Langley Battery (CTB) is located at the Langley Greer #4. The production from the five wells will go into a header and then into a three phase production separator. Each well will be tested once per month to quantify oil, water and gas by sending the production to a three phase test separator via turbine meters installed on the three phase test separator and the gas allocation meter. There are two oil tanks at the centralized tank battery that the wells will utilize and total oil will be measured by having qualified field personnel gauge the tanks. The CTB is located in the SW/4 NW/4 of Section 21, Township 22S, Range 36E on a Fee Lease. For gas there is a central delivery point (CDP) gas sales meter. The produced water will go to one common water tank on location.

Each well will be tested monthly through a three-phase test separator located at the Langley Greer 4 CTB. Oil and water are measured by a turbine meters on the oil and water outlets and gas is measured by an orifice meter on the gas outlet.

Production will be allocated to each well by monthly well tests. A 24 hour test will be performed monthly on each well. Each wells share of the central tank battery's total production will be calculated based on the results of each monthly well test. This ratio will be applied to the total oil production metered by tank gauging. This method will also be applied to the total gas production metered by the DCP Sales meter.

These meters will be calibrated on a regular basis per API and NMOCD specifications. The OCD will be notified of any future changes in the facilities.

**Process and Flow Descriptions:**

The flow of production is shown in detail on the enclosed process flow diagram and facility diagram maps which show the lease boundaries, well locations, flow line location, CTB, and gas sales meter. The commingling of this

production is the most effective economical means of producing the reserves and will not result in reduced royalty or improper measurement of production. The proposed commingling will reduce footprint, reduce traffic, and lower overall emissions.

Chevron U.S.A. Inc. understands that the requested approval will not constitute the granting of any right-of-way or construction rights not granted by the lease instrument.

All royalty and overriding interest owners will be notified. Chevron is the only working interest owner.

Inc. respectfully requests administrative approval to surface commingle oil, gas and water production from the Langley Strawn Pool through Chevron's Langley Greer 4 Central Tank Battery. Chevron requests the approval to minimize surface disturbance, future traffic and reducing spill risk by concentrating activities at one battery. Wells producing to this battery include the Langley Boren #2, Langley Boren #3, Langley Greer #1, Langley Greer #2, and Langley Greer #4. These wells are located in Section 20 and 21, T 22S, R 36E in Lea County, New Mexico.

The working interest varies among the wells but the royalty rate is the same for all leases involved in this request. These wells were completed in 1978, 1988, 1990, 1991, & 2008. Each well will be tested monthly through turbine meters installed on the three phase separator and the gas allocation meter. 
